
## When Indiana police officers respond to a car accident, most investigating officers fill out an Indiana

page. The first series of boxes in the upper left hand corner concern "contributing circumstances" for a car accident. There are 43 different codes for possible contributing factors, including (1) for "alcoholic beverages," (4) for "driver apparently asleep," (5) for "driver inattention" and (7) for "unsafe speed." Other boxes along the margin that can make a significant difference for how much money you receive for your accident include Box 23, which concerns a "victim's injury status." If you believe your injury was more
